

Life-event e-Gov services


Slovakia aims for eGov services to support life-events of citizens and businesses






eGovernment shall cover both state government and municipal services. Most of municipal offices are not ready to participate on eGov services yet.

- Over 2900 municipalities in Slovakia
- More than 1100 small villages up to 500 residents (320 000 total population)
- In category 500 to 2 000 residents cca. 1 300 municipalities (more than 1,3 mil. residents in total)
- Municipality competencies: 1. direct,
 - 2. government delegated
- Direct competencies wide variety of services
- Low number of transactions per office
- Lack of IT infrastructure and skills mainly in small offices








DCOM Services

- Municipal eServices to public eGov services covering original municipal competencies
- eServices for collaboration with state administration
- Use of eGovernment services

Benefits of Proposed Solution

138 services delivery that follow from direct municipal competencies

IT infrastructure cost reduction in municipal offices

Unified way of municipal eServices delivery even in small villages **Reduction of direct, face to face services and corresponding costs**

Certified back-office solutions for municipal offices, central support and upgrades

Solution integration to central eGov modules and registers

Reduced demand for office staff IT skills and decreased dependency on local IT support

Better use of centralized ICT infrastructure




Funding Model

The project of building DCOM is co-financed by Structural Funds within the Operational Programme Informatization of Society (OPIS).

- Investment Costs
 - 95 % EU Structural Funds
 - 5% own budget
- **Operating Costs** municipalities participated 100 %
 - either by direct payment (per head/per year), or
 - as a part of Proportionate Tax



Operational Model




